ORDINANCE 05-2010

**AN ORDINANCE ESTABLISHING SALARY RANGES
FOR THE CITY OF ABSECON**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ABSECON CITY,
NEW JERSEY** that this ordinance hereby amends portions of ordinance 24 of 2007 and
14 of 2008. This ordinance reads as follows:

1. Commencing on January 1, 2010, the annual salary or compensation paid to each of the officers or employees of the City of Absecon City holding a position under a classification established and set forth in the Ordinance shall be and the same is hereby fixed and determined within the range set forth.

2. The salary, wage or compensation of each of the Officers or employees named in section one of this ordinance shall be paid every two weeks in 26 equal installments.
3. Those employees exempted from additional compensation for working “official holidays”, as identified in the code of the City of Absecon, Chapter 61, Personnel, Sections 4 and 5, and those employees exempted from the payment of overtime, who meet the definition of Executive, Administrative, or Professional under the Federal Fair Labor Standards Act and the State Wage & Hour Law shall include:
 - a. Any and all employees considered part-time, or otherwise identified as those whose workweek is less than 35 hours per week.
 - b. Any and all employees who are considered department heads, deputy department heads, supervisors or managers. These shall include as herein identified, but shall not be limited to:
 1. Administrator
 2. Tax Collector
 3. City Clerk
 4. Chief Financial Officer
 5. Construction Official
 6. Chief of Police
 7. Public Works Supervisor
4. Any Ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of any such inconsistency.
5. This Ordinance shall take effect upon final adoption and publication as required by Law.
